IHCP to update procedure code rates for Money Follows the Person - Aged and Disabled Waiver services

Effective February 22, 2019, the Indiana Health Coverage Programs (IHCP) will update the reimbursement rates for the procedure code/modifier combinations listed in Table 1 for Money Follows the Person – Aged and Disabled (MFP – A&D) Waiver services. These rate changes will be applied retroactively to dates of service (DOS) on or after **July 1, 2018**.

Table 1 – MFP – A&D Waiver service rate changes, effective for DOS on or after July 1, 2018

Procedure code/ modifier	Description	Rate effective through June 30, 2018	Rate effective on or after July 1, 2018
T2022 U7	Case management, per month	\$100	\$150
T2025 U7 U1	Pest control services	\$600	\$4,000

Beginning February 22, 2019, claim detail lines that paid for these procedure code/modifier combinations with DOS on or after July 1, 2018, will be mass adjusted. Providers should see the adjusted claims on Remittance Advices (RAs) beginning March 27, 2019, with internal control numbers (ICNs)/Claim IDs that begin with 52 (mass replacement non-check related). For claims that were underpaid, the net difference will be paid and reflected on the RA. These rate changes will be reflected in the next regular update to the *Professional Fee Schedule*, accessible from the [IHCP Fee Schedules](#) page at in.gov/medicaid/providers.

Sign up now for spring 2019 IHCP provider workshops

The Indiana Health Coverage Programs (IHCP) invites providers to attend free, educational workshops at various locations throughout the state, from February 19 through March 28, 2019. See [Table 2](#) for specific workshop locations and dates.

Provider relations representatives from Anthem, CareSource, MDwise, Managed Health Services (MHS), and DXC Technology (DXC) will share general policy updates and billing guidance along with specific sessions focused on community health workers, substance use disorder residential treatment, applied behavioral analysis (ABA), and podiatry services. Updates on the centralized enrollment and credentialing project, FSSA EnCred, and on the fee-for-service (FFS) nonemergency transportation broker, Southeastrans, will also be provided.



All workshops will be held from 9 a.m. to 3:45 p.m. Each workshop will feature the same sessions, as described below. Session presentations will be posted on the [Spring 2019 IHCP Provider Workshops](#) page at in.gov/medicaid/providers in advance of the workshop dates. If desired, providers can print copies of the presentations for reference during the workshops. **Paper copies of the presentations will not be provided onsite.**

Session descriptions

■ DXC Technology – Tips and Reminders (9 a.m. - 9:45 a.m.)

This session will cover the new 180-day timely filing limit rules, including exclusions and extenuating circumstances to waive or extend the timely filing limit. Guidelines on charging members and changes to the Presumptive Eligibility (PE) process will also be reviewed.

■ Southeastrans – FFS Nonemergency Medical Transportation Broker (9:45 a.m. - 10:30 a.m.)

Southeastrans will review their portal, including the Facility, Member, and Provider panels. An overview of call center procedures as well as provider expectations will be discussed. Q&As regarding the most recent emergency medical services (EMS) changes will be provided.

■ Conduent – FSSA EnCred (10:45 a.m. - 11:30 a.m.)

This presentation will provide information related to the implementation of the Family and Social Services Administration (FSSA) EnCred system and will include an overview of functionality, current status, timelines, and benefits of the new solution. A demonstration of several of the enrollment and credentialing functions will be performed.

■ MDwise – 2019 MDwise Updates (12:30 p.m. - 1:15 p.m.)

This session will provide an in-depth review of the changes coming to MDwise providers in 2019, including new claim submission information, updated prior authorization (PA) guidelines, a new transportation vendor, and a new process for requesting claim adjustments.

■ Hoosier Care Connect Hospice Changes (1:15 p.m. - 2 p.m.)

Anthem and MHS will provide a high-level overview of hospice requirements and billing guidance for managed care entity (MCE) notifications and obtaining prior authorization.

■ Podiatry Services (2:15 p.m. - 2:30 p.m.)

This session will offer an overview of IHCP podiatry benefits, benefit limitations, and billing guidelines. (CareSource engagement specialists will present but the content is not CareSource-specific.)

■ Community Health Workers (2:30 p.m. - 2:45 p.m.)

Discussion will include the coverage of community health workers and how they can benefit our underserved communities. (MDwise representatives will give the presentation but the content is not MDwise-specific.)

■ SUD Residential Treatment (2:45 p.m. - 3 p.m.)

This session will offer a general overview of IHCP SUD residential treatment services, including enrollment and billing guidelines. (MHS representatives will present but the content is not MHS-specific.)

■ ABA Changes (3 p.m. - 3:15 p.m.)

This overview will describe the applied behavior analysis (ABA) codes released in the 2019 Healthcare Common Procedure Coding System (HCPCS) update and the billing guidance related to the new codes. (Anthem representatives will present but the content is not Anthem-specific.)

■ **Roundtable Discussion with MCEs** (3:15 p.m. - 3:45 p.m.)

This session will be an open forum for providers to ask questions and discuss issues with managed care entities.
