IHCP will no longer cover HCPCS code S9446

Effective June 7, 2019, the Indiana Health Coverage Programs (IHCP) will no longer cover Healthcare Common Procedure Coding System (HCPCS) code S9446 – *Patient education, not otherwise classified, non-physician provider, group, per session.* This change applies to all IHCP programs for dates of service (DOS) on or after June 7, 2019. Any claims with DOS before June 7, 2019 will be unaffected.



The Office of Medicaid Policy and Planning (OMPP) has decided that HCPCS code S9446 will be noncovered because it was used exclusively by an obsolete program, the Indiana Chronic Disease Management Program (ICDMP).

This change will be reflected in the next regular update to the *Professional Fee Schedule*, and the *Outpatient Fee Schedule*, accessible from the *IHCP Fee Schedules* page at in.gov/medicaid/providers.

IHCP clarifies change to FQHC cost report for Fiscal Year 2019

Effective June 1, 2019, Medicaid federally qualified health center (FQHC) providers must include non-reimbursable costs associated with Medicaid Rehabilitation Option (MRO) services for calculating prospective payment reimbursement rates. This applies to cost reports on or after June 1, 2019.

Because of an increased number of FQHC facilities operated by community mental health centers (CMHCs), the IHCP has updated the cost report's non-reimbursable costs section to include line 22.2 MRO Services. This line is included because MRO services cannot be reimbursed as FQHC services.



Updated instructions for completing the FQHC cost report for Fiscal Year 2019 and filing it with the State are available in the <u>FQHC Cost Report Instructions and Manual</u> on the Myers and Stauffer website at mslc.com.

Note: In a clinic where FQHC and CMHC providers render services, the FQHC provider must include their separate place of service (POS) code when billing. The CMHC provider must bill MRO services with their correct provider number.
