## FSSA updates annual limits and rates for certain A&D and TBI waiver services, mass adjusts claims

The Indiana Family and Social Services (FSSA) Office of Medicaid Policy and Planning (OMPP) is announcing changes to services provided under the Division of Aging (DA) Aged and Disabled (A&D) and Traumatic Brain Injury (TBI) waivers. The Centers for Medicare & Medicaid Services (CMS) approved corrections to the recent waiver renewal and allowed increases to annual limits for the services in Table 1. The new annual limits are effective immediately, retroactive to claims with dates of service (DOS) on or after **February 1, 2020**.



Table 1 - Changes to annual limits for A&D and TBI waiver services, effective February 1, 2020

Service	Code	Modifiers	Old annual limit	New annual limit
Home Modifications – Maintenance	S5165	U7, U8	\$500/year	\$1,000/year
Specialized Medical Equipment – Replacement or Repair	T2029	U7, U8	\$500/year	\$1,000/year
Vehicle Modifications – Maintenance	T2039	U7, U8	\$500/year	\$1,000/year

The Indiana Health Coverage Programs (IHCP) identified a claim-processing issue that affects fee-for-service (FFS) claims for the A&D and TBI waiver services in Table 1 with DOS on or after February 1, 2020. Claim details for these services may have paid incorrectly based on the old annual limits.

The claim-processing system has been corrected. Claims processed during the indicated time frame for these services will be mass adjusted. Providers should see adjusted claims on Remittance Advices (RAs) beginning November 18, 2020, with internal control numbers (ICNs)/Claim IDs that begin with 52 (mass replacement non-check related).

To align with the rate increases scheduled to go into effect February 1, 2020, the rates for the TBI waiver services in Table 2 are being increased. (The increased rates are the same as the current rates for the A&D waiver.) The rate increases for the TBI waiver services are effective immediately, retroactive to claims with DOS on or after **February 1, 2020**.

The IHCP identified a claim-processing issue that affects FFS claims for the TBI waiver services in Table 2 with DOS on or after February 1, 2020. Claims may have paid incorrectly based on the old rates.

The claim-processing system has been corrected. Affected claims processed during the indicated time frame that paid incorrectly will be mass adjusted. Providers should see the adjusted claims on RAs beginning November 18, 2020, with ICNs/Claim IDs that begin with 52 (mass replacement non-check related). For claims that were underpaid, the net difference will be paid and reflected on the RA.

These changes will be reflected in the next regular update to the *Professional Fee Schedule*, accessible from the *IHCP Fee Schedules* page at in.gov/medicaid/providers.
