Corrections to ICD-10 annual updates for BPHC, Hospice, and OB-GYN services

Indiana Health Coverage Programs (IHCP) Provider Bulletin <u>BT201765</u> announced information regarding 2017 updates to the ICD-10 diagnosis and procedure codes effective for IHCP as of October 1, 2017. Within that bulletin, errors were made in the tables related to Behavioral and Primary Healthcare Coordination (BPHC) and hospice services diagnosis codes as well as a table related to obstetrical and gynecological (OB-GYN) services procedure codes. Corrections to those tables are outlined in this bulletin. The table numbers in this bulletin correspond to the table numbers in the original publication, for reference purposes.

Behavioral and Primary Healthcare Coordination diagnosis code (Table 1)

In error, the diagnosis code listed in Table 1 was transposed; the associated description was correct. A corrected Table 1 is republished here for ease of reference.

Table 1 – Qualifying ICD-10 diagnosis code for BPHC added,
effective for DOS on or after October 1, 2017

Diagnosis code	Description
F5082	Avoidant/restrictive food intake disorder

Hospice diagnosis codes (Table 4)

In error, the diagnosis codes listed in Table 4 did not include diagnosis code I50812 – *Chronic right heart failure*. A corrected Table 4 is republished here for ease of reference.

Obstetrical and gynecological services (Table 6)

In error, the ICD-10 procedure codes listed in Table 6 did not include 0UT9FZL – *Resection of Uterus, Supracervical, Via Natural or Artificial Opening With Percutaneous Endoscopic Assistance*. A corrected table 6 is republished here for ease of reference.

0UT98ZL	Resection of Uterus, Supracervical, Via Natural or Artificial Opening Endoscopic
0UT9FZL	Resection of Uterus, Supracervical, Via Natural or Artificial Opening With Percutaneous Endoscopic Assistance
