Updates to the Preferred Diabetic Supply List announced

The Indiana Family and Social Services Administration (FSSA) established Abbott Diabetes Care, Roche Diabetes Care, and Trividia Health as preferred vendors for diabetic supplies for the Indiana Health Coverage Programs (IHCP), effective January 1, 2017. The Preferred Diabetes Supply List (PDSL) was created to identify the blood glucose monitors and diabetes test strips preferred for all IHCP programs, subject to limitations established for certain benefit packages. Updates to the PDSL are published periodically.



Effective April 1, 2018, Roche Diabetes Care is changing the name of a product on the PDSL, from ACCU-CHEK[®] Aviva blood glucose monitor to ACCU-CHEK[®] Aviva Plus. The change is to the name and packaging only and does not impact the function or characteristics of the meter itself or its corresponding blood glucose test strips. Table 1 provides an updated list of all products on the PDSL, effective for dates of service (DOS) on or after April 1, 2018.
