# IHCP clarifies annual filing requirements for Schedule X in Medicaid nursing facility reimbursement

Changes have been made in the Value-Based Purchasing program that affect reimbursement to nursing facilities providing Medicaid services. These changes include the calculation of the Nursing Facility Quality Rate Add-On for Medicaid rates effective July 1, 2019. Nursing facilities are required to complete the revised Schedule X and submit as described in this bulletin.



## **Revised Schedule X and filing requirements**

Schedule X has been revised effective January 1, 2019. Accordingly, for Medicaid rates effective July 1, 2019, nursing facilities providing services to Medicaid residents are required to file the *Schedule of Staff Retention (Schedule X) – Part 1* and the *Schedule for Advance Care Planning Training (Schedule X) – Part 2* for use in determining the Total Quality Score.

Schedule X – Part 1 is required to be completed for the calendar year ended December 31, 2018, and is due by **March 31, 2019**. All nursing facility employees should be included on the Schedule of Staff Retention regardless of which personnel line the costs are reported. Nursing facilities that do not submit Schedule X – Part 1 by March 31, 2019, will receive zero quality points for this quality measure.

Schedule X – Part 2 is required to be submitted for employees completing the advance care planning training through the Relias system by June 30, 2019, and is due by **July 31, 2019**. Please note that a minimum of one employee must have completed, on or before **June 30, 2019**, a level one advance care planning training program. Nursing facilities that do not have an employee that has completed the advance care planning training by June 30, 2019, shall receive zero quality points for this quality measure. Employee learners can register in Relias system on the <u>Registration</u> page at fssa.training.reliaslearning.com.
