IHCP removes residential habilitation (daily) services from requirement to document using EVV

The Indiana Health Coverage Programs (IHCP) previously announced in *IHCP Bulletin* <u>BT201855</u> an electronic visit verification (EVV) solution that will enable providers to meet the requirement to document personal care and home health services rendered as required by the *21st Century Cures Act*. The bulletin also listed the personal care services procedure code and modifier combinations for which the IHCP would require providers to document using EVV. However, following additional review, the IHCP is removing the residential habilitation procedure code and modifier combinations in Table 1 from the requirement.

- Personal care services January 1, 2020
- Home health services January 1, 2023
