## **IHCP updates Preferred Diabetic Supply List**

The Indiana Family and Social Services Administration (FSSA) selected Abbott Diabetes Care, Roche Diabetes Care, and Trividia Health as preferred vendors for diabetic supplies for the Indiana Health Coverage Programs (IHCP), effective January 1, 2017 (see *IHCP Bulletin* <u>BT201684</u>).

The Preferred Diabetes Supply List (PDSL) was created to identify the blood glucose monitors and diabetes test strips preferred for all IHCP programs, subject to limitations established for certain benefit packages. Updates to the PDSL are published periodically.



Effective October 1, 2019, the IHCP is adding the Accu-Chek Guide Me Retail Care Kit to the PDSL. The new meter uses the Accu-Chek Guide test strips currently on the Indiana Medicaid formulary. Table 1 provides an updated list of all products on the PDSL, effective for dates of service (DOS) on or after October 1, 2019.
