FSSA announces amendment to the Adult Mental Health Habilitation program

The Indiana Family and Social Services Administration (FSSA) has received approval from the Centers for Medicare & Medicaid Services (CMS) for an amendment of the Adult Mental Health Habilitation (AMHH) State Plan benefit. The approved amendment is effective April 1, 2020.

The approved amendment to the AMHH State Plan benefit makes the program more accessible for members and removes administrative burden for providers. The changes to the AMHH State Plan benefit include:

- The eligibility age will be changed from 35 years and older to 19 years and older.
- The required Adult Needs and Strengths Assessment (ANSA) score will be changed from 4 and above to 3 and above.
- The justification section for each service requested will be removed from the AMHH application. The consumer will be assigned a service package.

All services covered under the AMHH program are applicable for an additional prior authorization (PA) option. This will allow additional units to be authorized above the initial listed limit. Additional units can be requested via the Data Assessment Registry Mental Health and Addiction (DARMHA) system. The State Evaluation Team (SET) will review all PA requests and approve or deny additional units requested.

The code tables in this bulletin list service packages that have had their maximum allowed amount increased. The new maximum is the total allowed amount combined for the codes with each package. The maximum is the allowed amount per package period, which remains unchanged for each service.
