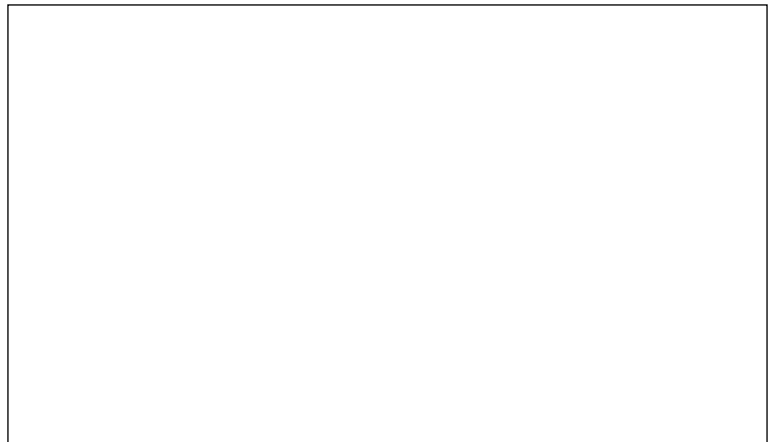

## **Virtual 2020 IHCP Roadshow presentations now available; Q&A webinars the week of April 27, 2020**

### **Roadshow presentations**

The Indiana Health Coverage Programs (IHCP) moved the 2020 IHCP Roadshow to a virtual format. This change, as previously announced in *IHCP Banner Page [BR202012](#)*, is in compliance with the State directive for social distancing because of the coronavirus disease 2019 (COVID-19).

The prerecorded Roadshow presentations are now available on the [2020 IHCP Roadshow](#) web page at [in.gov/medicaid/](http://in.gov/medicaid/) providers, and include talks by managed care entities (MCEs) – Anthem, CareSource, MDwise, and Managed Health Services (MHS). The Office of Medicaid Policy and Planning (OMPP), and DXC Technology also gave presentations. Each is available as a separate recording on the web page. Providers are encouraged to watch all of the presentations as each includes important updates.

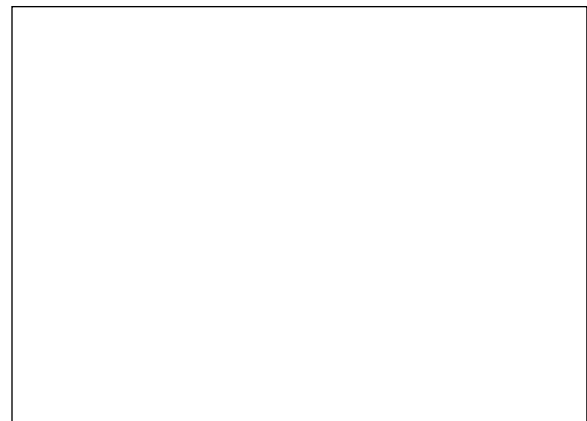

To participate in a webinar, go to <https://indiana.adobeconnect.com/ompp> to sign in. Ensure that Guest is selected, type your name, and click **Enter Room**.

Please note:

- The audio will be voice-over-internet, so participants will need to use speakers or headphones to hear the presentation.
- Prior to the webinar, participants can go to [https://indiana.adobeconnect.com/common/help/en/support/meeting\\_test.htm](https://indiana.adobeconnect.com/common/help/en/support/meeting_test.htm) to test the connection. The test will prompt the user for any updates or add-ins needed to participate in the webinar
- Do not log in to the webinar using Citrix or a virtual private network (VPN) because these services will not be able to play back audio.
