IHCP to cover COVID-19 vaccine for children ages 5 through 11

On Oct. 29, 2021, the U.S. Food and Drug Administration (FDA) authorized the use of the Pfizer coronavirus disease 2019 (COVID-19) vaccine for children ages 5 through 11 years old. The Indiana Health Coverage Programs (IHCP) has received Current Procedural Terminology (CPT^{®1}) codes from the American Medical Association (AMA) for the vaccine and its administration.

Effective immediately, for dates of service (DOS) on and after **Oct. 29, 2021**, the IHCP will reimburse IHCPenrolled providers for administration of the Pfizer COVID-19 vaccine to children ages 5 through 11. As established



in *IHCP Bulletins <u>BT2020129</u>, <u>BT202102</u> and <u>BT202172</u>, Emergency Medical Service (EMS) providers and pharmacies will be allowed to bill the vaccine administration codes. Vaccinations can be administered to all eligible IHCP members meeting vaccine Emergency Use Authorization (EUA) criteria who are age 5 through 11 years old. There is a dosing interval of 21 days from the first dose to the second dose. Any additional requirements or limitations specified by the Indiana Department of Health or the Centers for Disease Control and Prevention (CDC) must also be met.*

COVID-19 vaccination reimbursement is carved out of managed care benefits. Professional claims for managed care and fee-for-service (FFS) members should be submitted to the FFS claim-processing vendor, Gainwell Technologies. Pharmacy claims for managed care and FFS members should be submitted to the FFS pharmacy benefit manager, OptumRx, as announced in *BT202172*.

COVID-19 vaccines are to be supplied free of charge, without copay, to all IHCP members, including members in limited benefit categories, such as Emergency Services Only (ESO). COVID-19 vaccination claims for IHCP members who are dually eligible for both Medicare and Medicaid must be billed to the member's Medicare plan provider.

* Providers should note that the vaccine is available at no charge to providers at this time. Therefore, the IHCP will pay at zero until further notice.

Updates to pharmacy claim processing

Effective immediately, the IHCP pharmacy benefit has made changes to its claim-processing system to reimburse for administration of COVID-19 vaccines authorized for children ages 5 through 11 years. As established in *IHCP Bulletins* <u>BT2020127</u> and <u>BT202118</u>, this includes pharmacist-ordered vaccines administered by qualified pharmacists or pharmacist-supervised pharmacy interns and technicians.

Pharmacy providers must submit vaccine administration pharmacy claims using point-of-sale (POS) National Council for Prescription Drug Programs (NCPDP) codes as described in Table 2.

The member's age must correspond to the EUA or FDA labeling of the COVID-19 vaccine dose administered. Pharmacy claims for doses that do not correspond to the EUA or FDA labeling for that dose will deny displaying NCPDP reject code 76 – *Plan Limitation Exceeded* and will provide additional messaging pertaining to the age limits.

Reminders

Pharmacy providers administering COVID-19 vaccinations should instruct members to do the following:

- Use the same pharmacy for both vaccinations.
- Receive the second dose on the date specified by the manufacturer's product labeling.
