Additional changes being made to CIH and FSW services, effective Jan. 1, 2022

Effective Jan. 1, 2022, the Indiana Family and Social Services Administration (FSSA) Office of Medicaid Policy and Planning (OMPP) will update annual limits for certain services administered by the Division of Disability and Rehabilitative Services (DDRS) Community Integration and Habilitation (CIH) Waiver and Family Supports Waiver (FSW). Initial changes to the transportation services rate were made pursuant to House Enrolled Act 1001 to implement a 14% rate increase specifically to increase the wages of direct support professionals (DSPs) for the CIH Waiver and FSW, which were effective July 1, 2021. Per the direction from the Centers for Medicare & Medicaid Services (CMS), Specialized Medical Equipment and Vehicle Modifications are being implemented as two services, with separate annual limits.

Effective for dates of service on or after Jan. 1, 2022, DDRS is making changes to the annual limits for the following services:

- Specialized Medical Equipment, Install
- Specialized Medical Equipment, Repair/Maintenance
- Vehicle Modification, Install
- Vehicle Modification, Repair/Maintenance
- Transportation (FSW annual limit change only)



Table 1 presents the new limits for the services.
