## Corrected outpatient reimbursement information provided for select annual 2021 HCPCS codes

The Indiana Health Coverage Programs (IHCP) previously announced coverage and billing information for new codes for the annual Healthcare Common Procedure Coding System (HCPCS) updates in *IHCP Bulletin BT202109*. The outpatient reimbursement for procedure codes 92650–92653 and 93241–93247 was listed incorrectly in *BT202109*. These codes are not manually priced for outpatient reimbursement at a percentage of the amount billed. The IHCP uses national billing standards for these services.



Procedure code 93244 – *Heart rhythm review, and interpretation of continuous external EKG over more than 48 hours up to 7 days* is not separately reimbursable when the service is rendered in the outpatient facility setting.

The procedure codes listed in Table 1 may be reported to the IHCP on outpatient claims using standard billing guidance. The nationally linked revenue codes reimburse the flat fee of the revenue code in the outpatient setting for dates of service (DOS) on or after **January 1, 2021**.

*Table 1 – Procedure codes with outpatient pricing corrected to follow flat-rate revenue code methodology, effective retroactively for DOS on or after January 1, 2021*

92650	Screening evaluation of brain response to sound with automated analysis
92651	Evaluation of brain response to sound for determination of hearing status with interpretation and report
92652	Evaluation of brain response to sound for determination of hearing threshold with interpretation and report
92653	Evaluation of brain response to sound for diagnosis of nervous system disorders with interpretation and report
93241	Heart rhythm recording, analysis, report, review, and interpretation of continuous external EKG over more than 48 hours up to 7 days
93242	Heart rhythm recording continuous external EKG over more than 48 hours up to 7 days
93243	Heart rhythm analysis and report of continuous external EKG over more than 48 hours up to 7 days
93245	Heart rhythm recording, analysis, interpretation and report of continuous external EKG over more than 1 week up to 1 weeks
93246	Heart rhythm recording of continuous external EKG over 8-15 days
93247	Heart rhythm analysis and report of continuous external EKG over 8-15 days
