IHCP updates coverage for behavioral health diagnosis codes

As announced in *Indiana Health Coverage Programs (IHCP) Bulletin BT202288*, the annual 2023 International Classification of Diseases (ICD) code update included several diagnosis codes for the Medicaid Rehabilitation Option (MRO) Child and Adolescent Needs and Strength Assessment (CANS) and Adult Needs and Strength Assessment (ANSA) groups as well as the Behavioral and Primary Healthcare Coordination (BPHC) program. After further review, the Family and Social Services Administration (FSSA) determined that these codes do not meet criteria for coverage and should be removed.

Effective immediately, and retroactive to dates of service (DOS) on or after Oct. 1, 2022, the diagnosis codes listed in Table 1 have been removed from the ANSA (MRO Services-Adult) and CANS (MRO Services-Children and Adolescents) groups as well as the BPHC program.



Updates will be made to *Medicaid Rehabilitation Option (MRO) Services Codes* and *Behavioral and Primary Healthcare Coordination (BPHC) Codes*, accessible from the [Codes Sets](#) page at in.gov/medicaid/providers.

Table 1 – Diagnosis codes removed from the ANSA and CANS groups and BPHC program, effective for DOS on or after Oct. 1, 2022

Diagnosis code	Description
F1090	Alcohol use, unspecified, uncomplicated
F1091	Alcohol use, unspecified, in remission
F1191	Opioid use-unspecified, in remission
F1291	Cannabis use, unspecified, in remission
F1391	Sedative, hypnotic or anxiolytic use, unspecified, in remission
F1491	Cocaine use, unspecified, in remission
F1591	Other stimulant use, unspecified, in remission
F1691	Hallucinogen use, unspecified, in remission
F1891	Inhalant use, unspecified, in remission
F1991	Other psychoactive substance use, unspecified, in remission
T43652D	Poisoning by methamphetamines intentional self-harm, subsequent encounter
T43652S	Poisoning by methamphetamines intentional self-harm, sequela

Diagnosis code added for bridge appointments

Effective for DOS on or after Oct. 1, 2022, the ICD-10 diagnosis code in Table 2 will be added to the list of allowable diagnosis codes for bridge appointments. This update will be reflected in the *ICD-10 Diagnosis Codes for Bridge Appointments* table on *Behavioral Health Services Codes*, accessible from the [Code Sets](#) page at in.gov/medicaid/providers.

Table 2 – Diagnosis code added for bridge appointments, effective for DOS on or after Oct. 1, 2022

Diagnosis code	Description
T43652A	Poisoning by methamphetamines intentional self-harm, initial encounter
