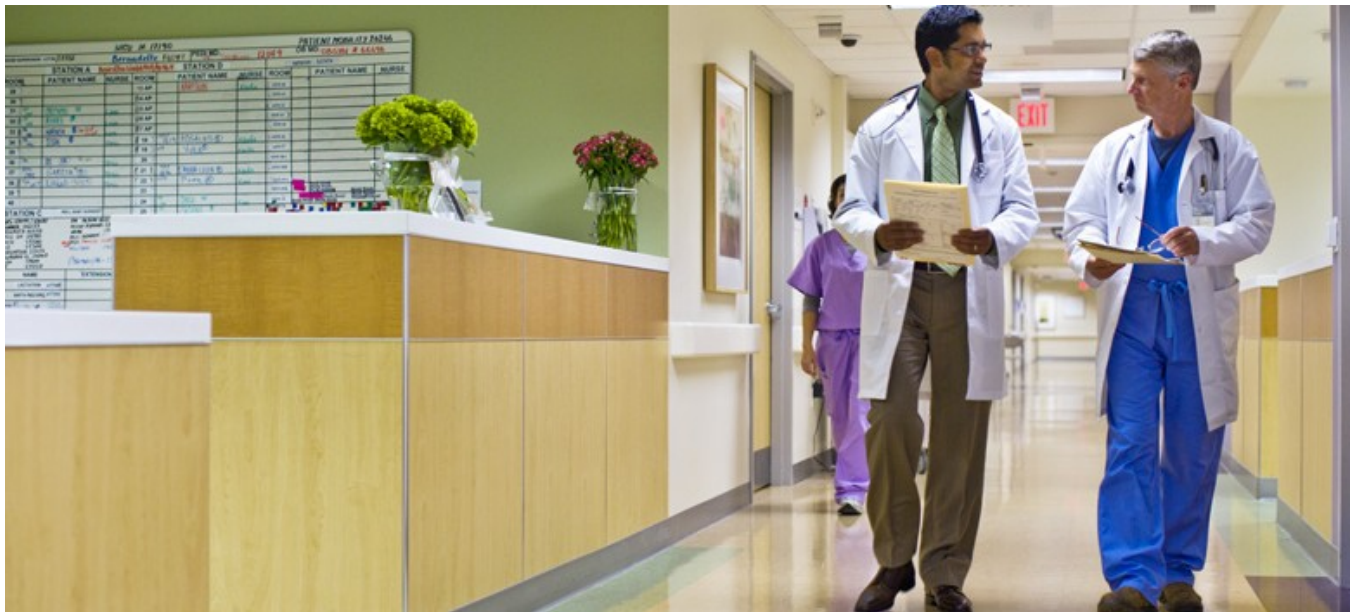

## Acute partial hospitalization and third-party liability

Effective July 1, 2010, the Indiana Health Coverage Programs (IHCP) began covering acute partial hospitalization for mental health using Current Procedural Terminology (CPT<sup>®1</sup>) Code S0201 – *Partial Hospitalization Services, less than 24 hours, per diem*. Providers inquired about the need to bill third-party insurance prior to submitting claims to Medicaid. Acute partial hospitalization is not a Medicaid Rehabilitation Option Service, and the IHCP requires that third-party insurance, including commercial carriers and Medicare, be billed prior to submission of the claim to Medicaid. For more information about the process for billing claims when a member has coverage through another insurer or policy, see *Chapter 6 of the IHCP Provider Manual*.

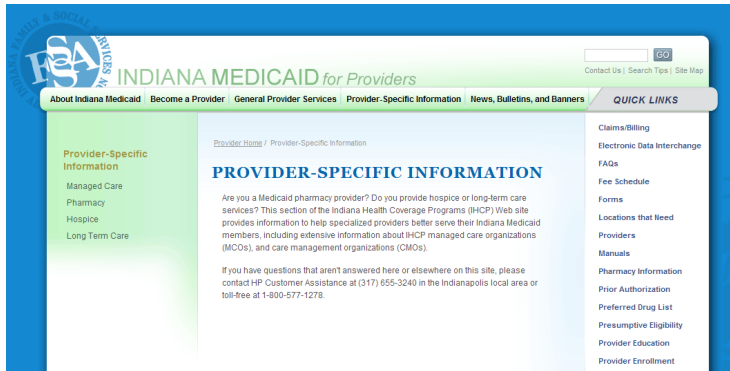
