## **Drug Enforcement Administration Nationwide Prescription Drug Take-Back Day Is September 25**

On September 25, 2010, the Drug Enforcement Administration (DEA), in partnership with local government, community, public health, and law enforcement agencies, will hold the first-ever nationwide prescription drug take-back day. To help prevent increased rates of prescription drug abuse and diversion, the DEA will provide this safe and anonymous way for the public to rid medicine cabinets of potentially dangerous expired, unused, and unwanted prescription drugs. Collection sites across the country will be open from 10 a.m. – 2 p.m. September 25 and may be located using the search system on the [DEA Web site](#). ## **Plan now to attend the National Correct Coding Initiative (NCCI) Workshop**

By participating in training via Virtual Room, providers do not need to leave their offices for important training. Office staff can simply log on to the Virtual Room and dial in to the conference line.
