CPT code linked to ambulatory surgical center revenue codes and pricing indicator

Effective April 1, 2011, the Indiana Health Coverage Programs (IHCP) has linked Current Procedural Terminology^{®1} (CPT) code 36596 – *Mechanical removal of intraluminal (intracatheter) obstructive material from central venous device* to the ambulatory surgical revenue codes 490 and 361 – *OR/minor surgery* for dates of service on or after April 1, 2011. An ambulatory surgical center (ASC) pricing indicator of 4 has also been linked to this procedure code effective April 1, 2011.

The IHCP clarifies partial hospitalization policy

The current policy on partial hospitalization (PH) for mental health services is defined in 405 IAC 5-20-8 and was published June 15, 2010, in Indiana Health Coverage Programs (IHCP) bulletin [BT201019](#). According to BT201019, PH programs must include four to six hours of active treatment per day and treatment must be provided at least four days a week.

If a provider does not offer treatment at this minimum level, the individual services rendered (for example, therapy) must be billed instead of billing PH.

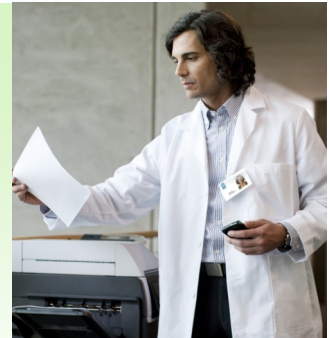
PH is covered for mental health services under the conditions above with the following clarification: If the Indiana Medicaid member is unable to attend the required four to six hours per day, four days per week, the provider may bill PH, as long as the provider offers the PH service four to six hours per day at least four days per week. If the provider does not offer services four to six hours per day at least four days per week, he or she may not bill for PH, but should bill as outlined in BT201019.
