## 2012 Healthcare Common Procedure Coding System updates are available

The 2012 Healthcare Common Procedure Coding System (HCPCS) updates are available for download on the [Centers for Medicare & Medicaid Services \(CMS\) website](#) at [cms.hhs.gov > HCPCSReleaseCodeSets > ANHCPCS](#).

The new codes, deleted codes, codes with description changes, and new modifiers are currently under review. A bulletin containing information about Indiana Health Coverage Programs (IHCP) coverage, prior authorization requirements, and pricing, as applicable, is planned for publication the last week of December 2011.

### Coverage and reimbursement for revenue code 881 – Ultrafiltration

Effective January 1, 2012, for dates of service on or after January 1, 2012, the Indiana Health Coverage Programs (IHCP) will provide coverage for revenue code 881 – *Ultrafiltration*. Consistent with the IHCP's outpatient dialysis services reimbursement, revenue code 881 will reimburse a composite rate at a maximum flat fee of \$41.30. Revenue code 881 will be reimbursable only for dates of service on which no other dialysis services were provided. As a stand-alone service, a maximum of one unit of service for each date of service is allowed.

## CPT code 95930 linked to optometrists

Effective January 1, 2012, the Indiana Health Coverage Programs (IHCP) will reimburse provider specialty 180 – *Optometrists* for Current Procedural Terminology (CPT<sup>®1</sup>) code 95930 – *Visual evoked potential (VEP) testing central nervous system, checkerboard or flash* when billed with one of the following diagnoses codes, for dates of service on or after January 1, 2012.

*Diagnosis codes linked to CPT code 95930 for optometrists – for dates of service on or after January 1, 2012*

ICD-9 Diagnosis	Description
340	Multiple sclerosis
368.40	Visual field defect, unspecified
V17.2	Family history of neurological disease, specifically multiple sclerosis

## CPT code 32553 assigned an ambulatory surgical center pricing indicator of 5

Effective January 1, 2012, for dates of service on or after January 1, 2010, the Indiana Health Coverage Programs (IHCP) has assigned Current Procedural Terminology (CPT<sup>®1</sup>) code 32553 – *Placement of interstitial devices for radiation therapy guidance (e.g., fiducial markers, dosimeter), percutaneous, intra-thoracic, single or multiple* an ambulatory surgical center (ASC) pricing indicator of 5. Providers with claims for dates of service on or between January 1, 2010, and December 31, 2011, which denied with error code 4108 – *No ASC on file* may resubmit those claims. For claims past the timely filing deadline, providers must resubmit claims with a copy of this banner article for proof of timely filing.

## The IHCP to cover CPT code 90654 – *Intradermal Flu Vaccine*

Effective December 15, 2011, the Indiana Health Coverage Programs (IHCP) will provide coverage for Common Procedural Terminology (CPT<sup>®1</sup>) code 90654 – *Influenza virus vaccine, split virus, preservative-free, for intradermal use* provided to members ages 18 years to 64 years old with dates of service on or after May 1, 2011. Providers that submitted claims for CPT code 90654 for members within the stated age parameters and with dates of service on or after May 1, 2011, which were denied with error code 4021 – *Procedure code is not covered for the dates of service for the program billed* may resubmit those claims.

The IHCP provider [Code Sets](#) on indianamedicaid.com have been updated to reflect this coverage change.
