

How ready are you for ICD-10?

Tell us in the second ICD-10 Provider Readiness Survey, which releases February 7

The *International Classification of Diseases, 10th Revision* (ICD-10), is set to implement October 1, 2013. Will you be ready?

The Indiana Health Coverage Programs (IHCP) continues to prepare – and help providers and vendors prepare, as well. The next ICD-10 IHCP Provider Readiness Survey begins February 7. The provider readiness surveys gather information about providers' preparations for implementing ICD-10, so the IHCP can provide useful links to websites and materials helpful to providers as they prepare for ICD-10.



ICD-10 vendor readiness surveys

Vendor readiness surveys are helping the IHCP uncover possible problems and determine how well vendors are prepared to implement ICD-10. A vendor readiness survey is scheduled to go out every 90 days until ICD-10 implementation. IHCP vendors received the second ICD-10 Vendor Readiness Survey November 7, and invitations for a third survey will be sent February 6 by email or U.S. Mail.

Results of the vendor and provider readiness surveys are posted on Web interChange, and are included in monthly Family and Social Services Administration (FSSA) and HP presentations to associations and at workshops. HP Provider Relations consultants also cover survey results when conducting on-site visits with providers.
