

### New reimbursement for rental of continuous passive motion exercise device (for use other than knee)

Effective April 1, 2012, for dates of service on or after January 1, 2007, the Indiana Health Coverage Programs (IHCP) has assigned RR – *Rental of Durable Medical Equipment* pricing to Healthcare Common Procedure Coding System code E0936 – *Continuous passive motion exercise device for use other than knee*. Providers must bill E0936 with modifier RR for reimbursement. The maximum reimbursement rate for E0936 RR is \$19.10. The <u>Fee Schedule</u> will be updated on indianamedicaid.com to reflect this coverage and reimbursement information.

Providers with claims for dates of service between January 1, 2007, and March 31, 2012, that denied with error code 4209 – *No matching pricing segment for the procedure/modifier combination* may resubmit those claims. For claims past the

timely filing deadline, providers must resubmit claims with a copy of this banner article for proof of timely filing.

## CPT codes 37765 and 49422 linked to revenue code 490

For dates of service on or after April 1, 2012, the Indiana Health Coverage Programs (IHCP) has linked Current Procedural Terminology (CPT<sup>®1</sup>) codes 37765 – *Stab phlebectomy of varicose veins, 1 extremity; 10 to 20 stab incisions* and 49422 – *Removal of tunneled intraperitoneal catheter* to revenue code 490 – *Ambulatory surgical care*. For reimbursement, providers must bill the procedure code and the revenue code together for dates of service on or after April 1, 2012.
