

Individual Education Plan (IEP) nursing rate for calendar year 2012

Pursuant to the State Plan, the annual reimbursement rate for Current Procedural Terminology (CPT^{®1}) code 99600 TD TM – *IEP related nursing services* was calculated for dates of service January 1, 2012, through December 31, 2012. Consistent with the methodology previously employed, the new rate is calculated based on the most recent home health cost reports required from all home health providers billing the Indiana Health Coverage Programs (IHCP) for services. For dates of service on or after January 1, 2012, the maximum reimbursement rate for 99600 TD TM is \$10.49 per 15 minutes. The [Fee Schedule](#) will be updated on indianamedicaid.com to reflect the new rate. Coverage policy and billing instructions as stated in [BT201108](#), and outlined in [Chapter 8](#) of the *IHCP Provider Manual*, remain the same.

Providers may adjust claims that were paid at the lesser rate for dates of service on or after January 1, 2012. The adjustments can be easily identified with region code 50 on the Remittance Advice.

Indiana Pharmacy Benefit Manager changes its name from ACS to Xerox

Two years ago, the Indiana Health Coverage Program's (IHCP's) Pharmacy Benefit Manager, Affiliated Computer Services (ACS), was acquired by Xerox. Since the acquisition, ACS has marketed itself as "ACS, A Xerox Company." Because of progress in uniting ACS with Xerox, the ACS brand is being retired. Providers will now see marketing and communications material referring to Xerox as the IHCP Pharmacy Benefit Manager.
