

Revenue code linkages for CPT code 86336 and HCPCS code Go283

For dates of service on or after August 1, 2012, the Indiana Health Coverage Programs (IHCP) has linked Current Procedural Terminology (CPT^{®1}) code 86336 – *Inhibin A* to revenue codes 302 – *Lab/immunology* and 309 – *Lab/other*. For

dates of service on or after August 1, 2012, the IHCP has linked Healthcare Common Procedure Coding System (HCPCS) code G0283 – Electrical stimulation (unattended), to one or more areas for indication(s) other than wound care, as part of a therapy plan of care to revenue code 430 – Treatments occupational therapy.

Outpatient billing instructions for **CPT codes 94780 and 94781**

To allow for the appropriate reimbursement of the base and add-on code, providers should bill Current Procedural Terminology (CPT) code 94780 - Car seat/bed testing for airway integrity, neonate, with continual nursing observation and continuous recording of pulse oximetry, heart rate and respiratory rate, with interpretation and report; 60 minutes with revenue code 460 - Pulmonary function; and CPT code 94781 - Car seat/bed testing for airway integrity, neonate, with continual nursing observation and continuous

recording of pulse oximetry, heart rate and respiratory rate, with interpretation and report; each additional full 30 minutes (List separately in addition to code for primary procedure) with revenue code 469 - Other pulmonary function. Consistent with the National Correct Coding Initiative's (NCCI's) medically unlikely edits, CPT code 94780 reimburses a maximum of one unit, and CPT code 94781 reimburses a maximum of two units. The following table shows the linkages for these procedure and revenue codes.

Billing and reimbursement changes for revenue codes 460 and 469

To bring the Indiana Health Coverage Programs (IHCP) billing instructions for revenue codes in alignment with national coding guidelines, the Office of Medicaid Planning and Policy (OMPP) is reviewing revenue codes and identifying those that require procedure codes. Two revenue codes identified are 460 – Pulmonary function and 469 - Other pulmonary function. For dates of service on or after July 1, 2012, a procedure code will be required for revenue codes 460 and 469. For claims submitted on or after July 1, 2012, if a procedure code is not billed with revenue code 460 or revenue code 469, the detail will deny for explanation of benefits (EOB) code 9077 - A procedure code is required when billing this revenue code. If an incorrect procedure code is billed with revenue code 460 or 469, the detail will deny for EOB





520 - Invalid revenue code procedure code combination. The following tables show procedure codes billable with revenue codes 460 and 469.


Additionally, to allow for the proper reimbursement of base and add-on procedures codes associated with these revenue codes, for claims with dates of service on or after July 1, 2012, the maximum flat rate reimbursement of revenue code 469 will be changed to equal that of revenue code 460 (\$36.37). The OMPP expects minimal impact on providers, based on the historical claims submission and use of revenue code 469.
