## Billing and coverage policies revised for certain LOCM procedure codes

The Indiana Health Coverage Programs (IHCP) reviewed the coverage and billing policies for low osmolar contrast material (LOCM) procedure codes. It was determined that separate reimbursement under revenue code 636 is appropriate for the LOCM procedure codes listed in the following table. Effective July 15, 2012, for dates of service on or after July 1, 2012, the following procedure codes may be billed with revenue code 636 for IHCP reimbursement consideration. The fee schedule on indianamedicaid.com will be updated to reflect the procedure code and revenue code linkages.

### LOCM procedure codes that may be billed with revenue code 636 effective for dates of service on or after July 1, 2012

Code	Description	Revenue code
Q9965	Low osmolar contrast material, 100-199 or greater mg/ml	636
Q9966	Low osmolar contrast material, 200-299 or greater mg/ml	636
Q9967	Low osmolar contrast material, 300-399 or greater mg/ml	636

Additionally, it was determined that certain LOCM products are not currently available. Therefore, effective July 15, 2012, for dates of service on or after July 1, 2012, the LOCM procedure codes listed in the table on the next page will be noncovered.

### LOCM procedure codes that are noncovered effective for dates of service on or after July 1, 2012

Code	Description	
Q9951	Low osmolar contrast material, 400 or greater mg/ml iodine concentration	
Q9953	Injection, iron-based magnetic resonance contrast agent, per ml	
Q9955	Injection, perflexane lipid microspheres, per ml	

Coverage and reimbursement for all other LOCM procedure codes remain unchanged.
