# The IHCP improves age-specific auditing

Effective September 26, 2012, the Indiana Health Coverage Programs (IHCP) will implement changes to the code editing logic for edit 4034 - Procedure code billed not compatible with recipient's age. Please verify and resubmit. Currently, edit 4034 considers years of age only. For claims received on or after September 26, 2012, the code editing logic for edit 4034 will adjudicate claims based on days, months, and years of age. Edit 4034 will post when a member's days, months, and years of age are not compatible with the age designation of the IHCP-covered Healthcare Common Procedure Coding

System (HCPCS) and Current Procedural Terminology (CPT<sup>®1</sup>) code billed. Providers that receive denials on claims for edit 4034 are encouraged to verify the age designation for the code in question and resubmit a corrected claim for reimbursement consideration.

# Update to NCCI and code auditing edits on the claim detail level

The Indiana Health Coverage Programs (IHCP) applies National Correct Coding Initiative (NCCI) and code auditing edits to medical services billed on the CMS-1500 claim form. Validation currently occurs on the following criteria: header level billing provider, same member, same date of service.

Effective September 26, 2012, the NCCI and code auditing edits will use the rendering provider National Provider Identifier (NPI) at the detail level of the claim for additional validation criteria. As a result, providers will experience fewer erroneous denials for edits 4181, 4194, 4196, and 4197.

Edit code	Edit code description	Purpose of edit
4181	Service denied due to a National Correct Coding (NCCI) edit. Go to the CMS website for information regarding NCCI coding policies.	This edit code identifies when the detail on a profes- sional (CMS-1500) claim has denied for Column I and II and Mutually Exclusive (ME) edits.
4194	Evaluation & management codes not reimbursable on same day of surgery	This edit code identifies when the units of service al- lowed on the claim detail exceed the Medically Unlikely Edit (MUE) unit limit, as defined by the Cen- ters for Medicare & Medicaid Services (CMS).
4196	Evaluation & management codes not reimbursable during pre-op period	This edit code identifies when the detail on a profes- sional claim has denied for a pre-operative visit the day before a major surgery.
4197	Evaluation & management codes not reimbursable during post-op period	This edit code identifies when the detail on a profes- sional claim has denied for a post-operative visit.

Code auditing edits for rendering provider
