IHCP is transitioning to a new Interactive Voice Response system

The Indiana Health Coverage Programs (IHCP) is transitioning to a new voice over Internet protocol (VoIP) telephone technology February 4, 2013. As part of this change, the Automated Voice Response (AVR) system will be upgraded to an Interactive Voice Response (IVR) system, allowing for a more interactive experience for users. Initial improvements include eliminating use of the pound sign during menu selections as well as adding the ability to exit the IVR system and speak to a live call center representative. Further improvements will be implemented throughout 2013 to enhance and improve the user's experience. Subsequent improvements will be announced prior to their implementation.

1099 tax forms will be mailed no later than January 31

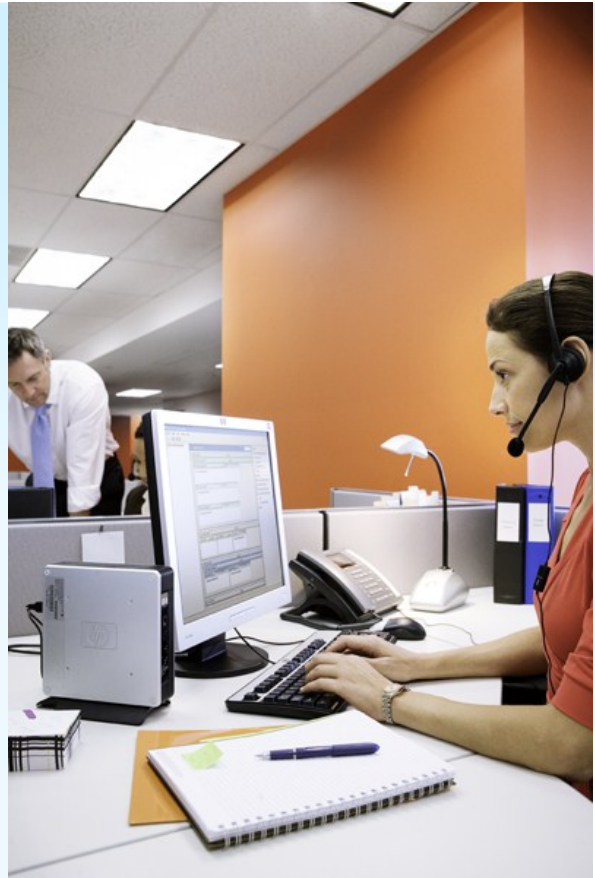
HP will produce and mail all Medicaid 1099 tax forms no later than January 31, 2013, in compliance with Internal Revenue Service rules and regulations.
