IEP transportation mileage claims to be mass adjusted or reprocessed

A system error resulted in incorrectly paid Individualized Education Program (IEP) transportation mileage claims billed by provider specialty 120 – *School Corporations* with dates of service (DOS) from July 1, 2010, through December 26, 2012, inclusive. These claims incorrectly reimbursed all mileage billed without subtracting the first 10 miles per IHCP reimbursement policy. As stated in *IHCP Provider Manual Chapter 8*, Section 4, in the *Transportation Services: Mileage* subsection, "Although the IHCP automatically deducts the first 10 miles of a CAS [common ambulatory services] or NAS [nonambulatory services] trip from each one-way trip, CAS and NAS providers must bill for all mileage (including the first 10 miles) to ensure proper reimbursement. For trips less than 10 miles, the IHCP does not require the provider to bill mileage; however, if the provider does bill mileage, the IHCP processes the mileage as a denied line item."

The system error has been corrected and all claims with DOS on or after December 27, 2012, will reimburse according to policy. Transportation mileage claims billed by provider specialty 120 – *School Corporations* with DOS from July 1, 2010,

through December 26, 2012, will be mass adjusted or reprocessed. The mass adjustment or reprocessing will begin appearing on the January 29, 2013, Remittance Advice (RA) and will be identified with internal control numbers (ICNs) that begin with region code 56 (mass adjusted) or 80 (mass reprocessed). For claims that were overpaid, the net difference will appear as an accounts receivable and will be recouped at 100% from future claims paid to the respective provider.

J2791 – Injection, Immune Globulin linked to revenue code 636

Effective March 1, 2013, the Indiana Health Coverage Programs (IHCP) has linked procedure code J2791 – *Injection, RHO(D) Immune Globulin (Human), (Rhophylac), Intramuscular or Intravenous, 100 IU*, to revenue code 636 – *Codes requiring detailed coding.* Providers may bill the procedure code and revenue code together, as appropriate, for dates of service (DOS) on or after March 1, 2013.
