Coverage changes for S0201 and H0035

Under current policy, the Indiana Health Coverage Programs (IHCP) covers partial hospitalization, which is a component of mental health services. Partial hospital (PH) programs are highly intensive, time-limited medical services intended to provide a transition from inpatient psychiatric hospitalization to community-based care or, in some cases, substitute for an inpatient admission. Effective July 1, 2010, the IHCP began covering acute partial hospitalization for mental health services.

Coding and Billing Changes

The following coding and billing changes will be effective September 1, 2013:

- Healthcare Common Procedure Coding System (HCPCS) code S0201 – *Partial hospitalization services, less than 24 hours, per diem* will no longer be a covered code.
- HCPCS code H0035 – *Mental health, partial hospitalization, treatment, less than 24 hours* will be a covered code.

For dates of service on or after September 1, 2013, providers are instructed to use H0035 in place of S0201, as appropriate, to bill for partial hospitalization mental health services. The same limits and restrictions that applied to S0201 apply to H0035. As a reminder, partial hospitalization is limited to one unit per day and requires prior authorization.

Updates to FQHC and RHC Encounter Codes

Effective September 1, 2013, the Current Procedural Terminology (CPT^{®1}) and Healthcare Common Procedure Coding System (HCPCS) codes shown in Table 1 were added as valid Federally Qualified Health Center (FQHC) and Rural Health Clinic (RHC) encounter codes for dates of service on or after January 1, 2013. FQHC and RHC providers that have billed and received denials for these codes for claims with dates of service on or after January 1, 2013, should resubmit those claims.
