## IHCP covers additional codes for influenza virus vaccine

Effective September 1, 2013, the Indiana Health Coverage Programs (IHCP) will provide coverage for Current Procedural Terminology (CPT<sup>®1</sup>) codes:

- 90685 Influenza virus vaccine, quadrivalent, split virus, preservative free, when administered to children 6 35 months of age, for intramuscular use and
- 90686 Influenza virus vaccine, quadrivalent, split virus, preservative free, when administered to children 3 years of age and older, for intramuscular use.

For reimbursement consideration, providers may bill these procedure codes, as appropriate, for dates of service (DOS) on or after September 1, 2013.

The provider <u>Code Sets</u> and <u>Fee Schedule</u> will be updated on indianamedicaid.com

to reflect this coverage and reimbursement information.

### Pricing for influenza virus vaccine CPT code 90672 updated

Effective September 1, 2013, the Indiana Health Coverage Programs (IHCP) is updating the pricing for Current Procedural Terminology (CPT) code 90672 – *Influenza virus vaccine, quadrivalent, live, for intranasal use*. The pricing for this procedure is changing from manual pricing to a maximum rate of \$22. This pricing change will apply to dates of service on or after July 1, 2013. The <u>Fee Schedule</u> will be updated at indianamedicaid.com to reflect this pricing update.

#### HCPCS Code S3870 linked to revenue codes 310 and 319

Effective September 1, 2013, the Indiana Health Coverage Programs (IHCP) has linked Healthcare Common Procedure Coding System (HCPCS) code S3870 – *Comparative genomic hybrization (CGH) microarray testing for developmental delay, autism spectrum disorder and/or mental retardation* to revenue codes 310 – *Pathology lab* and 319 – *Pathology/ other*. For reimbursement consideration, providers may bill the procedure code and revenue code together, as appropriate, for dates of service on or after September 1, 2013.

As a reminder, procedure code S3870 is subject to prior authorization.

#### HCPCS codes J2248 and J2315 linked to revenue code 636

Effective September 1, 2013, the Indiana Health Coverage Programs (IHCP) has linked Healthcare Common Procedure Coding System (HCPCS) codes J2248 – *Micafungin Sodium Injection* and J2315 – *Naltrexone, Depot Form* to revenue code 636 – *Drugs requiring detailed coding*. For reimbursement consideration, providers may bill these procedure codes and the revenue code together, as appropriate, for dates of service (DOS) on or after September 1, 2013.
