## CPT code 87660 linked to revenue codes 300/306/309

Effective July 1, 2014, the Indiana Health Coverage Programs (IHCP) will link Current Procedural Terminology (CPT®<sup>1</sup>) code 87660 – *Infectious agent detection by nucleic acid (DNA or RNA); Trichomonas vaginalis, direct probe technique* to the following revenue codes:

- 300 – *Laboratory-General*
- 306 – *Laboratory-Bacteriology and Microbiology*
- 309 – *Laboratory-Other Laboratory*

These linkages apply to dates of service (DOS) on or after **July 1, 2013**.

Beginning July 1, 2014, for reimbursement consideration, providers may bill CPT code 87660 and the revenue code together, as appropriate. Claims with DOS on or after July 1, 2013, that previously denied for explanation of benefits (EOB) 520 – *Invalid revenue code and procedure code combination* will be mass adjusted. Mass adjusted claims will begin appearing on the July 1, 2014, Remittance Advice (RA) and will be identified with internal control numbers (ICNs) that begin with region code 56.

## Timeframe revised for completing and submitting the ANSA assessment

The Indiana Family and Social Services Administration (FSSA) requires an Adult Needs and Strengths Assessment (ANSA) be conducted for adults with behavioral health disorders. Effective May 1, 2014, the timeframe for completing and submitting the ANSA was extended from 30 days to 60 days to allow additional time for providers to complete the assessment, as well as the application process for programs that require an application. Programs affected include Medicaid Rehabilitation Option (MRO), Behavioral and Primary Healthcare Coordination (BPHC), and Adult Mental Health Habilitation (AMHH).

## Pricing updated for HCPCS codes L4205 and L7520

Effective July 1, 2014, the Indiana Health Coverage Programs (IHCP) will update the pricing for the following Healthcare Common Procedure Coding System (HCPCS) codes:

- L4205 – *Repair of orthotic device, labor component, per 15 minutes*
- L7520 – *Repair prosthetic device, labor component, per 15 minutes*

The pricing for these procedure codes is changing from manual pricing to maximum-fee pricing. The IHCP will adopt Medicare's maximum fee rate for the listed codes for dates of service on or after July 1, 2014.

This pricing change will be reflected in the next monthly update to the [Fee Schedule](#) at [indianamedicaid.com](http://indianamedicaid.com).
