The IHCP updates FQHC and RHC encounter codes

Effective August 1, 2014, the Indiana Health Coverage Programs (IHCP) will add the Current Procedural Terminology (CPT^{®1}) and Healthcare Common Procedure Coding System (HCPCS) codes in Table 1 as valid Federally Qualified Health Center (FQHC) and rural health clinic (RHC) encounter codes. This update applies retroactively to dates of service (DOS) on or after **January 1, 2014**.

Beginning August 1, 2014, FQHC and RHC providers may submit claims for these codes with DOS on or after January 1, 2014. Claims for these codes with DOS on or after January 1, 2014, that previously denied may be resubmitted.

The IHCP will remove the CPT and HCPCS codes in <u>Table 2</u> on the next page from the list of valid FQHC and RHC encounter codes. These codes were deleted codes effective December 31, 2013, and therefore, are not considered valid encounter codes for DOS on or after **January 1, 2014**.

Correction: TOB code 32X to be used for home health services

Indiana Health Coverage Programs (IHCP) *Banner Page <u>BR201421</u>*, dated May 27, 2014, outlined the Indiana Health Coverage Programs' (IHCP's) decision to discontinue use of Type of Bill (TOB) code 33X when billing claims for home health services and instead use TOB code 32X. *BR201421* incorrectly stated that the change from TOB 33X to TOB 32X applied to claims with **dates of service** on or after July 1, 2014. In correction, providers are advised that the change applies to all **claims submitted** on or after July 1, 2014, regardless of the date of service.

Beginning July 1, 2014, providers should use TOB 32X for all claims submitted for home health episodes when billing home health services. Electronic data interchange (EDI) claims and claims submitted via Web interChange with TOB 32X will process without delay. A pending systems update to allow for TOB 32X on paper claims will delay processing. Paper claims submitted from July 1 through July 15, 2014, will be held and processed on July 16, 2014, once the system update is effective.

The TOB 32X will be billable in the same manner as the TOB 33X for all home health services. All claims submitted with **TOB 33X on or after July 1, 2014, will be denied**. For complete billing instructions, see <u>Chapter 8</u> of the IHCP Provider Manual.
