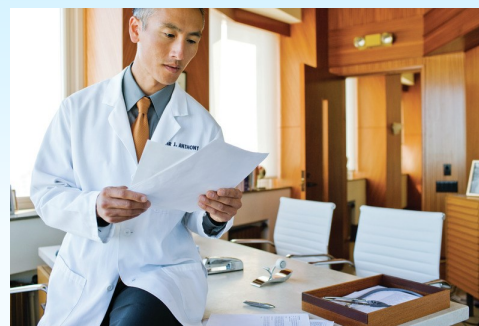

Providers may resubmit claims for HCPCS code Q3027 that denied incorrectly

The Indiana Health Coverage Programs (IHCP) has identified a claims processing system issue. Between January 1, 2014, and January 22, 2015, claim details billed with revenue code 636 and Healthcare Common Procedure Coding System (HCPCS) code Q3027 – *Injection, Interferon BETA -1A, 1 mcg for intramuscular use* may have inappropriately denied with an explanation of benefits (EOB) code 6000 – *Manual price required*. Claims billing revenue code 636 with HCPCS code Q3027 that denied for EOB code 6000 between January 1, 2014, and January 22, 2015, may be resubmitted for reimbursement consideration. Claims resubmitted beyond the original one-year filing limit must include a copy of this banner page as an attachment and must be filed within one year of the publication date.



IHCP to add ICD procedure codes to the claims processing system

Effective June 1, 2015, the Indiana Health Coverage Programs (IHCP) will add the ICD-9 procedure codes in Table 1 to the claims processing system as a corrective measure; these codes had previously not been included. Coverage of these codes will be retroactive to dates of service (DOS) on or after **July 1, 2014**. Beginning June 1, 2015, providers may submit claims for these codes for reimbursement consideration. Claims for these codes that previously denied may be resubmitted for reimbursement consideration. Claims submitted beyond the original one-year filing limit must include a copy of this banner page as an attachment and must be filed within one year of the publication date.

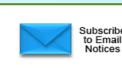
