## **IHCP to mass reprocess claims for CPT codes 59514 and 59620 that denied incorrectly**

The Indiana Health Coverage Programs (IHCP) has identified a claims processing issue that affects claims processed from July 1, 2014, through March 30, 2015, for the following Current Procedural Terminology (CPT<sup>®1</sup>) codes:

- CPT code 59514 – *Cesarean delivery only*
- CPT code 59620 – *Cesarean delivery only, following attempted vaginal delivery after previous Cesarean section*

Claims for these codes may have mistakenly denied for explanation of benefits (EOB) 4033 – *Invalid procedure code modifier combination*.

The claims processing system has been corrected to link the appropriate modifiers to the preceding CPT codes. The affected modifiers are shown in Table 1.

*Table 1 – Affected modifiers*

<b>Modifier</b>	<b>Description</b>
UB	Medically necessary delivery prior to 39 weeks gestation
UC	Delivery at 39 weeks gestation or later
80	Assistant surgeon
81	Minimum assistant surgeon
82	Assistant surgeon
AS	Assistant surgeon by P.A.

Claims processed during the indicated time frame that previously denied for EOB 4033 will be mass reprocessed. Providers should see the reprocessed claims on Remittance Advices (RAs) beginning September 8, 2015, with internal control numbers (ICNs) that begin with 80 (mass reprocess).

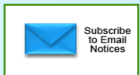
