Web interChange outage impacts PE applications September 5-8, 2015

The Indiana Health Coverage Programs (IHCP) Web interChange tool was unable to process eligibility transactions and Presumptive Eligibility (PE) applications from Saturday, September 5, 2015, through Tuesday, September 8, 2015. At a qualified provider's request, the eligibility date for members whose PE applications could not be successfully transmitted during that time frame will be backdated to reflect the date the initial processing attempt was made.



If qualified providers have not yet done so, they should enter the affected PE

applications into Web interChange as soon as possible. In cases where a member's eligibility date was impacted by the outage, providers should notify the IHCP that a correction to the PE effective date is needed. A copy of the member's approval letter indicating the corrected effective date for PE should be faxed to HP Provider Relations at (317) 488-5020. All affected applications must be entered and requests to correct effective dates received by October 2, 2015. Requests received after this date will not be processed.

Provider Relations will coordinate correction of the PE effective dates in the claims processing system and will mail PE approval letters to affected members. Once the dates are corrected, providers may bill or rebill claims with dates of service based on the member's new eligibility date.

Virtual training sessions scheduled for ICD-10

The Indiana Health Coverage Programs (IHCP) will implement ICD-10 on October 1, 2015, per federal mandate from the Centers for Medicare & Medicaid Services (CMS). The IHCP has scheduled four virtual sessions to educate providers on the processes and changes that will occur with the implementation of ICD-10.

Who is affected by ICD-10?

If you are required to use ICD-9 diagnosis codes on your claims, you will be required to use ICD-10 codes on claims for dates of service on or after October 1, 2015. Diagnosis codes are not currently processed on dental and non-durable medical equipment (DME) pharmacy claims. Dental and non-DME pharmacy claims are the only claims not affected by the implementation of ICD-10 at this time. *Dental providers do not need to attend the sessions*.

Information will include:

- ICD-10 general overview
- Preparation for the October 1 implementation date
- Testing
- Prior authorization submission prior to October 1
- All patient-refined/diagnosis-related group (APR/DRG) inpatient hospital rates and crosswalks

- September 29, 2015, 2:00 p.m. 4:30 p.m.

Test access to "HP MyRoom" before attending virtual provider training

The Indiana Health Coverage Programs (IHCP) is using a virtual training environment called HP MyRoom. All providers who plan to attend a virtual training session must download the HP MyRoom software to gain access to this training environment. You can download HP MyRoom from <u>myroom.hp.com</u>. When downloading the software, please remember that your system administrator may have limited your ability to download files from the Internet or to perform certain installation processes. Therefore, you may need to contact your IT department to request assistance with the download.

It is important that you download and test HP MyRoom at least a few days before attending a virtual training session. You do not need to create an account to download the software or to attend the virtual training sessions. After the software is installed, you will be prompted to enter your name and then click Join. Providers experiencing problems downloading or using HP MyRoom may call the IHCP Workshop Line at (317) 488-5072 for assistance.
