## IHCP updates the mileage rate for HCPCS code A0090

Effective May 12, 2016, the Indiana Health Coverage Programs (IHCP) will update the mileage rate paid for Healthcare Common Procedure Coding System (HCPCS) code A0090 – *Non-emergency transportation, per mile* – *vehicle provided by individual (family member, self, neighbor) with vested interest.* The rate will change from \$0.40 per mile to \$0.36 per mile. This change is retroactive to dates of service (DOS) on or after **February 22, 2016**. The mileage rate for A0090 is tied to the mileage rate State employees receive, and the Indiana Department of Administration reduced the mileage reimbursement State employees receive effective February 22, 2016.

Claims for DOS on or after February 22, 2016, that were paid incorrectly at the old rate will be mass-adjusted. Adjustments should appear on the provider Remittance Advices (RAs) beginning May 31, 2016, with internal control numbers (ICNs) that begin with 56 (mass adjusted). For claims that were overpaid, the net difference will appear as an accounts receivable. The accounts receivable will be recouped at 100% from future claims paid to the respective provider number.

### **Corrections made to new** Audiologist Code Set and Hearing Aid Dealer Code Set

As announced in <u>BR201609</u>, the Indiana Health Coverage Programs (IHCP) separated the previous *Hearing Services Code Set* table into two tables – one for audiologists (provider specialty 200) and one for hearing aid dealers (provider specialty 220), effective for



dates of service (DOS) on or after April 1, 2016. Corrections to the Audiologist Code Set were published in BR201611.

Additional corrections to these code sets have been made as follows:
