Modifiers RR and/or NU linked to certain manually priced DME HCPCS codes

Effective July 14, 2016, the Indiana Health Coverage Programs (IHCP) will link modifiers RR – *Rental of DME* and/or NU – *New DME* to the manually priced Healthcare Common Procedure Coding System (HCPCS) codes in Table 1. These linkages will apply retroactively to fee-for-service (FFS) claims with dates of service (DOS) on or after **July 1, 2015**.

Beginning July 14, 2016, providers may bill the HCPCS codes in Table 1 for DOS on or after July 1, 2015, with modifier RR or NU, as indicated in the table, for reimbursement consideration. Claim details billing the HCPCS codes in Table 1 on the affected DOS that previously denied for explanation of benefit (EOB) 4033 – *Invalid procedure code modifier combination* may be resubmitted. Claims resubmitted beyond the original one-year filing limit must include a copy of this banner page as an attachment and must be filed within one year of the publication date.



Table 1 – HCPCS codes to which modifiers RR and/or NU will be linked effective for DOS on or after July 1, 2015

HCPCS Code	Description	Modifiers to be Linked
A8003	Helmet, protective, hard, custom fabricated, includes all components and accessories	NU and RR
E1011	Modification to pediatric size wheelchair, width adjustment package (not to be dispensed with initial chair)	NU and RR
E1017	Heavy-duty shock absorber for heavy-duty or extra heavy-duty manual wheelchair, each	NU and RR
E1018	Heavy-duty shock absorber for heavy-duty or extra heavy-duty power wheelchair, each	NU and RR
E1231	Wheelchair, pediatric size, tilt-in-space, rigid, adjustable, with seating system	NU and RR
E2217	Manual wheelchair accessory, foam filled caster tire, any size, each	NU and RR
L9900	Orthotic and prosthetic supply, accessory, and/or service component of another HCPCS L code	RR
