IHCP makes updates to lab codes subject to HAF

The Indiana Health Coverage Programs (IHCP) will update the laboratory Current Procedural Terminology (CPT^{®1}) and Healthcare Common Procedure Coding System (HCPCS) procedure codes that are subject to the Hospital Assessment Fee (HAF). Outpatient laboratory services, defined as the procedure codes listed on the Medicare Clinical Laboratory Fee Schedule, are not eligible for HAF. The IHCP must reflect the 2017 Medicare Clinical Laboratory Fee Schedule in its claim processing for both fee-for-service (FFS) and managed care claims.

Effective September 15, 2017, updates regarding laboratory procedure codes subject to HAF will be made to the CoreMMIS claim processing system. This update will apply to FFS claims with dates of service (DOS) on or after September 15, 2017. These updates will be reflected on the next regular update to the [Outpatient Fee Schedule](#).

Billing guidance within the managed care delivery system is established and published by the individual managed care entities (MCEs). Questions should be referred directly to the individual MCEs.

The following indicates the general focus for the presentations on each of the three days:

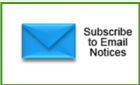
- Tuesday, October 17: Professional billing (CMS-1500)
