IHCP clarifies coordination requirements with Southeastrans for facility transport scenarios

The Indiana Health Coverage Programs (IHCP) works with Southeastrans to manage all nonemergency medical transportation (NEMT) for Traditional Medicaid members. The IHCP is clarifying when coordination through Southeastrans is required for certain types of facility-to-facility transports.

The following scenarios do require coordination of the transport through Southeastrans:

- A **nonemergency** transport of a member from one hospital to another, when the member is discharged from the first hospital and is being transported to the second hospital for inpatient admission
- A transport to move a member from one nursing facility to another nursing facility

The following scenarios do not require coordination of the transport through Southeastrans:

- An emergency transport from one hospital emergency room (ER) to another hospital ER, without a hospital admission at the first hospital, because the transport is considered a continuation of the emergency run
- An emergency transport from one hospital to another, when the member is discharged from the first hospital and is being transported to the second hospital for inpatient admission, because the transport is considered an emergency
- A hospital-to-hospital transport for specialized services associated with an inpatient admission that does not result in admission to the receiving hospital; the sending hospital is responsible for arranging and covering the trip.

The Indiana Family and Social Services Administration (FSSA) and its vendor, Southeastrans Inc., recently held a series of virtual town hall meetings to discuss changes related to the brokering of nonemergency medical transportation (NEMT) services for fee-for-service Medicaid members, which began June 1, 2018. The four webinars were directed toward Indiana Health Coverage Programs (IHCP) transportation providers, IHCP facility providers, and organizations working directly with affected IHCP members.

The meeting agendas addressed specific questions and issues related to policy and process changes for scheduling, rendering, and billing for NEMT transports. Portal enhancements allow providers to view dental, professional, and institutional claim attachments

In response to feedback from providers, the Indiana Health Coverage Programs (IHCP) will enhance the IHCP Provider Healthcare Portal (Portal) so providers can view the attachments submitted with dental, professional, and institutional claims.

Effective July 26, 2018, providers will be able to access this new function in the Portal by following these steps:





- 2. On the My Home page, select the Claims tab from the menu bar and select the Search Claims option; the Search Claims page will display.
- 3. On the Search Claims page, enter the claim, member, or service information requested and click Search; search results will display.
- 4. Identify the claim of interest from the search results and click the Claim ID link to view claim details.
- 5. In the Attachments panel of claim details, click the View link to view a document submitted as an attachment to the claim. See Figure 1.

Applied Behavioral Analysis PA Checklist updated

The Indiana Health Coverage Programs (IHCP) publishes an IHCP Applied Behavioral Analysis (ABA) Prior Authorization Checklist for providers to use in preparing prior authorization (PA) requests for ABA therapy. This voluntary tool, which is intended to help providers prepare comprehensive requests and reduce the need to suspend PA requests for additional information, has been updated. The updated checklist is available on the Forms page at indianamedicaid.com under the Prior Authorization section.

The checklist is relevant to PA information needed for both fee-for-service (FFS) and managed care ABA services. Questions about FFS PA should be directed to Cooperative Managed Care Services (CMCS) at 1-800-269-5720. Individual managed care entities (MCEs) establish and publish PA criteria within the managed care delivery system. Questions about managed care PA should be directed to the MCE with which the member is enrolled.


