- To expedite processing turnaround time for documents, EDS has changed post office (P.O.) boxes. - Joy Newby and Associates, Inc., will be conducting a series of workshops for Indiana Health Coverage Programs (IHCP) providers in April and May.

Multispecialty physician and nonphysician workshops will cover Medicaid-specific Current Procedural Terminology (CPT) and Health Care Financing Administration's (HCFA's) Common Procedure Coding System (HCPCS) coding changes for 2000, Medicaid changes in the Hoosier Healthwise Program, and Package C or Children's Health Insurance Program (CHIP) implementation and coverage, and other general Medicaid information. These workshops **will not** cover transportation, pharmacy, long-term care, dental, or facility billing for hospitals or ambulatory surgery centers (ASCs). These workshops are scheduled for the following dates:

May 11, 2000	Merrillville
May 18, 2000	Evansville

Specialty workshops for eye care providers will cover medical, surgical, and routine care to Medicaid and Medicare patients. This series will be broken into two sessions.

The morning sessions will cover only medical and surgical ophthalmic services. Topics of discussion will be Medicaid CPT and HCPCS coding changes for 2000, policy updates and clarification for eye care providers, Hoosier Healthwise changes, Package C or CHIP implementation and coverage, and other general Medicaid information.

The afternoon sessions will cover Medicare Durable Medical Equipment Regional Carrier (DMERC) and IHCP billing guidelines for optical services. The single specialty workshops for eye care providers are scheduled for the following dates:
