To All Indiana Health Coverage Programs Inpatient Mental Health Providers:

- Since December 28, 1999, some claims have been erroneously denied for Explanation of Benefit (EOB) Code 4083, *Inpatient care rendered in an Institution for Mental Health Disease is not covered for Package C. Please verify and resubmit*, and EOB Code 4085, *Inpatient care rendered in an Institution for Mental Health Disease is a Medicaid non-covered service for recipients ages 22 thru 64. Please verify and resubmit*. A systematic reprocessing project has been initiated and will appear on this week's remittance advice (RA) statement for claims erroneously denied since the December 28, 1999, RA statement date. Internal control numbers (ICNs) with 80 as the first two digits easily identify these claims. Until a permanent fix is made to the system, EDS will perform a weekly systematic reprocessing of claims denied the previous week. This will create a one-week delay in processing these claims. Due to systematic reprocessing, it is not necessary for providers to resubmit claims denied erroneously for EOB Codes 4083 and 4085. EDS will continue to keep providers updated with future banner page articles on this matter.
