Subject: National Drug Code Changes for Compound Drugs and Multiple NDC Codes

Overview

The Federal Deficit Reduction Act of 2005 mandates that the Indiana Health Coverage Programs (IHCP) requires the submission of National Drug Codes (NDCs) on claims submitted with certain procedure-coded drugs (see bulletins referenced below). The requirement for the NDC submission was implemented August 1, 2007, for professional claims and July 1, 2008, for outpatient claims.

In bulletins [BT200731](#) for outpatient/outpatient-crossover claims and [BT200713](#) for medical claims, instructions were published concerning how to bill compounds and multiple NDC codes for the same Healthcare Common Procedure Coding System (HCPCS) code. Effective for claims received on or after April 1, 2009, multiple-detail lines will be handled systematically, and special batching will no longer be required on physician-administered codes that require NDCs.

Multiple NDC Codes for Outpatient/Outpatient-crossover Claims

For claims submitted on or after April 1, 2009, when a provider bills two or more of the same HCPCS codes for the same member on the same date of service, the provider will no longer need to send these claims through Written Correspondence for special batching **if the NDCs are different**. Providers will bill the claims with the appropriate NDC codes for the drug they are administering on separate detail lines.

For example, if a provider administers 150mg of Synagis, he or she would most likely use a 50mg vial plus a 100mg vial. These two vials have separate NDC codes but share one unique procedure code, and would be submitted as two detail lines, as shown in Table 1.

Multiple NDC Codes for Medical Claims

Providers will no longer need to submit claims with the KP and KQ modifiers to represent multiple NDC codes for a single-procedure code. Providers will bill the claims with the appropriate NDC codes for the drugs they are dispensing on separate detail lines.

Billing Units of Service

When billing for a drug with the same NDC code and the same HCPCS code, for the same member on the same date of service, providers must combine the total units administered and use only one detail line.

It is imperative that, when billing for the same NDC code and the same HCPCS code, for the same member on the same date of service, providers use only one claim form and one detail line. If billed on more than one claim form or more than one detail line, the second detail or claim with the same procedure code and NDC will deny as a duplicate.

Claims with a quantity greater than 9,999.99 units will still need to be special batched. The claims processing system cannot process quantities greater than 9,999.99, and the quantity cannot be divided between multiple detail lines because the NDC code will be the same for each detail and will deny for duplicate. These claims will continue to be submitted on the appropriate paper claim form through Written Correspondence at the address below for special batching.

Compound Billing for Outpatient/Outpatient-crossover and Medical Claims Changes Effective April 1, 2009

In a previous publication, directions were given to bill compounds with revenue code 630 for outpatient/outpatient-crossover claims for each ingredient within the compound that has a procedure code. For claims submitted on or after April 1, 2009, compounds should be billed with revenue code 636 instead of revenue code 630. When billing compounds for **outpatient/outpatient-crossover claims**, each revenue code 636/procedure-code combination billed requires the submission of the NDC code, NDC quantity, and unit of measure.

When billing compounds for **medical claims**, each procedure code billed requires the submission of the NDC code, NDC quantity, and unit of measure.

By billing compounds as stated and utilizing NDC codes for each ingredient, any drugs used within the compound will be reimbursed appropriately.

Applicable Procedure Codes

Claims billed with the following procedure codes require the submission of the product NDC, NDC quantity, and NDC unit of measure (UOM), along with the procedure code and procedure code billing units. This list is reviewed and updated quarterly (January, April, July, and October) or as determined by the Office of Medicaid Policy and Planning (OMPP). Refer to the www.indianamedicaid.com Web site for the listing of procedure codes that require NDCs. The table is published under *Provider Services/Procedure Codes that Require an NDC*.

The list of procedure codes includes codes reviewed by the Medical Policy Department prior to January 1, 2009, but does not guarantee coverage of a particular procedure code. Please refer to the IHCP Fee Schedule for current procedure code coverage policies:
