# Pharmacy updates approved by Drug Utilization Review Board March 2015

The Indiana Health Coverage Programs (IHCP) announces changes to prior authorization (PA) criteria, the Preferred Drug List (PDL), and the Over-the-Counter (OTC) Drug Formulary as approved by the Drug Utilization Review (DUR) Board at its March 20, 2015, meeting.



## **PA** Changes

PA criteria for nonpreferred agents were established and approved by the DUR Board. These criteria will be effective for PA requests submitted on or

after May 1, 2015. The PA criteria are posted on the *Pharmacy Prior Authorization Criteria and Forms* page (Preferred Products > Pharmacy Criteria and Forms) via the <u>Pharmacy Services</u> quick link at indianamedicaid.com.

## Changes to the PDL and OTC Drug Formulary

Changes to the PDL and OTC Formulary were made at the March 20, 2015, DUR Board meeting. See Table 1 for a summary of PDL changes and Table 2 for a summary of OTC Drug Formulary changes. Changes are effective for dates of service (DOS) on or after May 1, 2015, unless otherwise noted.
