Inquiries are not used to submit claims; however, they serve as an avenue for providers to obtain claim- specific information or assistance with specific questions or claim problems.




Figure 1.1 – EDS Territory Map

Refer to the territory map (Figure 1.1) and the provider field consultant listing (Table 1.2 and Table 1.4) to determine the appropriate provider field consultant and telephone	The field consultants work closely with the provider community to explain the program's policies and objectives, assist in issue resolution, and conduct training seminars and onsite visits. Consultants can also provide additional information about electronic claims capture (ECC).
