Subject: New Hospice Rates Effective October 1, 2000

Overview

Effective October 1st of each year, the Health Care Financing Administration (HFCA) establishes and releases new hospice rates to state Medicaid agencies for Medicaid-enrolled hospice providers.

This bulletin provides the following information about the new Medicaid hospice rates:

- A brief explanation of the method of calculation used by Myers and Stauffer, LC, to establish the Indiana Health Coverage Programs (IHCP) hospice rates.
- A brief summary of how EDS, the IHCP's fiscal agent contractor, updated the Indiana AIM system to reflect the new hospice rates and the date mass claims adjustments were completed.
- A table that reflects the new IHCP hospice rates, effective October 1, 2000, as prepared by Myers and Stauffer, LC, the IHCP's longterm care rate-setting contractor.

Method of Calculation of IHCP Hospice Rates

As outlined in the IHCP hospice provider manual, reimbursement for the IHCP hospice benefit follows the methodology and level established by the HCFA for administration of the federal Medicare program. IHCP hospice rates are, therefore, based on Medicare reimbursement rates and methodologies, adjusted to disregard offsets attributable to Medicare premium amounts. The rates are adjusted for regional differences in wages using indices published by the HCFA. The total *per diem* amounts reimbursed to an IHCP-enrolled hospice provider are calculated according to the IHCP member's hospice level of care **and** the member's location of care, that is:

- Routine home hospice care delivered in the private home (IHCP hospice *per diem* only)
- Routine home hospice care delivered in a nursing facility (IHCP hospice *per diem* plus room and board *per diem*)
- Continuous home hospice care delivered in a private home (IHCP hospice *per diem* only)
- Continuous home hospice care delivered in a nursing facility (IHCP hospice *per diem* plus room and board *per diem*)
- Inpatient hospice care for private home members or nursing facility member (IHCP hospice *per diem* only), no additional room and board *per diem* is added for this service.

Payment of IHCP Hospice Claims at the New Hospice Rates

EDS loaded the new hospice rates into Indiana AIM December 22, 2000. The new hospice rates are reflected in Table 1.1.

Mass claims adjustments were completed January 5, 2001. Hospice providers were notified of the mass claims adjustments on the January 9, 2001 remittance advice (RA).

Mass adjustment requests are applied to change a large number of requests at one time. In this case, the Office of Medicaid Policy and Planning received formal notification from the Health Care Financing Administration (HCFA) regarding Medicaid hospice rates **after** the October 1, 2000 rate effective date so Indiana AIM could not be updated with the new hospice rates prior to the effective date. To ensure minimal disruption to hospice providers, the OMPP directed EDS to mass adjust hospice claims for dates of service on or after October 1, 2000. The reason for this mass adjustment request is because the new hospice rates for hospice procedure codes were changed retroactively.

A mass claims adjustment is identified on a RA statement with a Region code of 56. This means that the first two digits of the claim ICN are 56.
