

## Download the HP Summary Report of LTC **Facilities Reviewed**

Each month, the HP Long Term Care (LTC) staff members conduct on-site audits of Medicaidcertified LTC facilities, providing oversight for the Office of Medicaid Policy and Planning (OMPP) and the Division of Aging (DA). The audits help providers achieve compliance in documentation and billing, and also help ensure the health and safety of Indiana Health Coverage Programs (IHCP) members.

The current HP LTC monthly audit report, which contains information ranging from audit validation rates, to analyses by risk category, to summaries of monthly statistics for all facilities reviewed, is now available for download from the Monthly Summary Report of LTC Facilities Reviewed of indianamedicaid.com.





## Medicaid providers receive \$2,358,750 in **EHR** incentive reimbursements

Have you signed up for the Indiana Medicaid Electronic Health Records (EHR) Incentive Program? As of August 23, 2011, Indiana Medicaid providers have received \$2,358,750 in incentive reimbursements through the Indiana Medicaid EHR program. The program, which began in May 2011, provides financial incentives for eligible professionals and hospitals demonstrating meaningful use

## Reminder: Please make sure invoices for HCPCS code A4223 are clear

To avoid unnecessary claim denials, please make sure invoices submitted for Healthcare Common Procedure Coding System (HCPCS) code A4223 - Infusion supplies not used with external infusion pump, per cassette or bag (list drugs separately) are as clear as possible. Other tips:

- Let HP calculate reimbursement amounts, rather than trying to calculate them yourself.
- Be precise please don't submit multiple invoices for one code.
- Include the cost invoice or manufacturer's catalog page and indicate to which code it applies.



## **HIPAA 5010 testing status**

The Health Insurance Portability and Accountability Act (HIPAA) version 5010 compliance date of January 1, 2012, is fast approaching. All active clearinghouse, software vendor, and billing service trading partners are required to test transactions for 5010 compliance.

Indiana Medicaid is now testing the 5010 version, including the errata. The vendor testing period will continue until October 31, 2011.

The IHCP Upcoming Changes documents and IHCP 5010 Com-

panion Guides have been updated to contain errata version information and have been posted to indianamedicaid.com.

Providers must contact their software vendors, clearinghouses, or billing services to verify that they are testing with Indiana Medicaid.

## **Pharmacy news**

The IHCP adopts AAP recommendations regarding Synagis (palivizumab)

Late fall is the beginning of the season for respiratory infections, such as respiratory syncytial virus (RSV), which can be serious for newborns – particularly premature newborns. Please note that for dates of service on or after October 1, 2011, the Indiana Health Coverage Programs (IHCP) is adopting 2009 American Academy of Pediatrics (AAP) recommendations regarding the prophylactic RSV drug Synagis. You can find a copy of AAP's publication, Modified Recommendations for Use of Palivizumab for Prevention of Respiratory Syncytial Virus Infections (publication 1694), and related information on the AAP website at aap.org. Also see BT201143, dated August 30, 2011.

Synagis prescriptions require prior authorization. A Synagis Prior **Authorization Form is** available on indianamedicaid.com under **Pharmacy Forms**.

### New format for OTC Drug Formulary



As of October 1, 2011, the Over the Counter (OTC) Drug Formulary will be separated into a Pediatric OTC Drug Formulary for those 18 years of age and younger, and an Adult OTC Drug Formulary for those 19 years of age and older. The OTC Drug Formularies can be accessed at Myers and Stauffer, LC at in.mslc.com under Pharmacy > State MAC List. ## Flu shot Q&A

Q: Will members who receive a flu shot need a separate vaccine for H1N1?

A: This year's flu vaccine (shot) comprises three components, one of which is H1N1. That means a basic flu shot should provide defense against most strains of H1N1. A separate H1N1 vaccine isn't necessary.

Q: Who should get flu shots?

A: Flu shots are recommended for children, the elderly, and those with asthma or compromised immune systems.

Q: Does washing your hands really help prevent the spread of flu and other viruses?

A: Washing your hands; covering your mouth when you sneeze; and disinfecting common telephones, work surfaces, keyboards, and so on, will help prevent the flu and other viruses from spreading.
