

# Seventy percent of all IHCP trading partners have converted to HIPAA 5010

As of January 25, 2012, 70% of all Indiana Health Coverage Programs (IHCP) trading partners had successfully converted to *Health Insurance Portability and Accountability Act* (HIPAA) version 5010. All trading partners must be converted by March 31, 2012.

Trading partners that have not yet converted must:

- Submit a request to continue submitting claims in version 4010A1 (for details, see NL201201).
- Verify that your software vendor has completed testing for HIPAA 5010.
- Submit an updated <u>Trading Partner Profile</u>.
- Submit an updated <u>Trading Partner Agreement</u>.

After the IHCP receives your Trading Partner Profile and Agreement, you will be converted to HIPAA 5010. If you have questions, contact the EDI Solutions team at <a href="mailto:INXIXTradingPartner@hp.com">INXIXTradingPartner@hp.com</a>.



## NCPDP D.O: CMS grace period ends March 31, 2012

If you have not transitioned to National Council for Prescription Drug Programs (NCPDP) D.0, do it soon! All providers must have transitioned to NCPDP D.0 by March 31, 2012; as of January 24, 2012, approximately 7% of Indiana Health Coverage Programs (IHCP) providers were still submitting claims in version 5.1 format.

#### April 28 is the DEA's fourth National Prescription Drug Take-Back Day

The fourth Drug Enforcement Administration (DEA) National Prescription Drug Take-Back Day will be Saturday, April 28, 2012, from 10 a.m. - 2 p.m., providing consumers in every state with a safe means to dispose of unwanted, unused pre-

scription medications. The take-back service is free and anonymous, with no questions asked. Sites will accept tablets, capsules, and all other solid dosage forms of unwanted medication. The DEA will provide an online drug collection site locator on the DEA website at justice.gov/dea/ in March 2012. Consumers disposed of 498.5 tons of unwanted medication during the first three DEA National Prescription Drug Take-Back Days.

### Medicaid providers receive more than \$42 million in EHR reimbursements

As of February 1, 2012, Indiana Medicaid providers have received more than \$42 million in incentive reimbursements through the EHR incentive program, which provides financial incentives for eligible professionals and hospitals demonstrating meaningful use of certified EHR technology.
