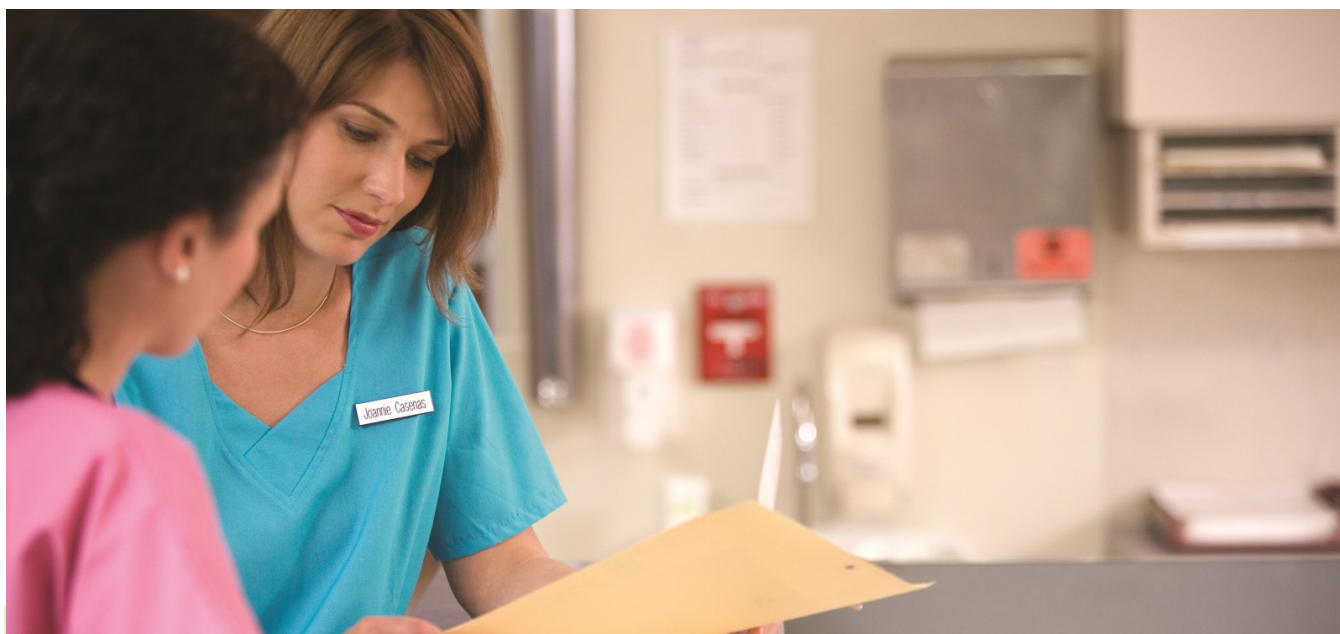

The IHCP has selected the 3M All Patient Refined (APR) Diagnosis-Related Group (DRG) as the grouper for the ICD-10

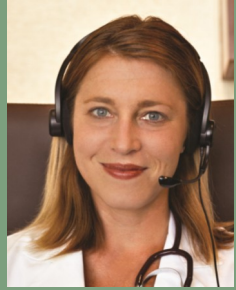

The [ICD-10 Training page](#) now includes a section called "IN Time Training." It features

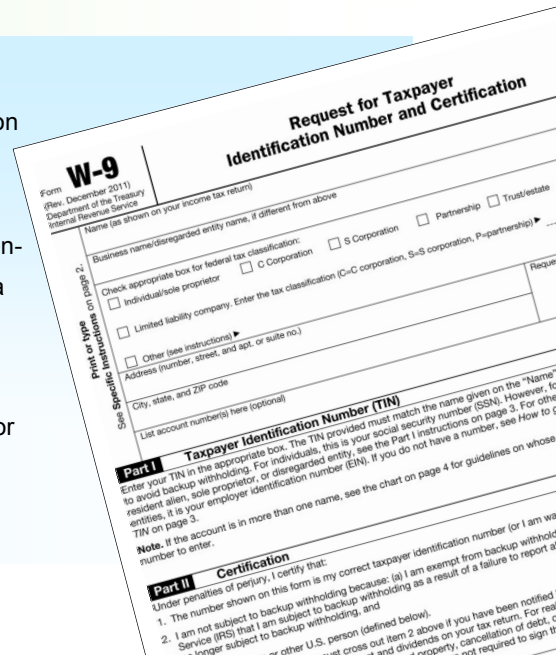

IN Time Training does not replace the need for in-depth ICD-10 coding and process training, but it will provide you with Indiana Medicaid-specific information. Be sure to fill out W-9s correctly

Business information, including Social Security numbers and business tax identification numbers (TINs), must be reported to the Indiana Health Coverage Programs (IHCP) on the Internal Revenue Service's (IRS') Form W-9. Whenever the information on the W-9 – your name, business' name, address, Social Security number, or Employer Identification Number – changes, you need to fill out a new Form W-9. When you submit a W-9, you certify that the TIN you are providing is correct and accurate.

Be sure to fill out your W-9 correctly! Incorrect W-9s can delay your IHCP enrollment and cause problems with tax reporting to the IRS. You can find detailed instructions for filling out the W-9 on the form itself.



The OMPP implements a Hospital Assessment Fee

The Indiana Hospital Association (IHA) and the Office of Medicaid Policy and Planning (OMPP) have worked together to develop and implement a hospital assessment fee program, in accordance with *Public Law 229-2011, Section 281*. Under this program, the OMPP will collect an assessment fee from eligible hospitals to be used in part to increase reimbursement to eligible hospitals for services provided in fee-for-service and managed care programs, and as the state share of disproportionate share hospital (DSH) payments. Are you getting your share of the EHR reimbursements?

Have you signed up for the Indiana Medicaid Electronic Health Records (EHR) Incentive Program? As of June 20, 2012, Indiana Medicaid providers have received more than \$66 million in incentive reimbursements through the EHR incentive program, which provides financial incentives for eligible professionals and hospitals demonstrating meaningful use of certified EHR technology. The IHCP addresses new requirement for OPR providers

For Medicaid to reimburse for services or medical supplies that require a provider's order, prescription, or referral, the *Affordable Care Act (ACA)* requires that the ordering, prescribing, or referring provider be enrolled in Medicaid. To address this new requirement, and to encourage nonenrolled providers to enroll in the Indiana Health Coverage Programs (IHCP), a new category of enrollment has been created: ordering, prescribing, referring (OPR) provider. POA indicator required for all Medicaid-enrolled hospitals effective July 1, 2012

When the Indiana Health Coverage Programs (IHCP) adopted the current Hospital Acquired Conditions (HAC) policy in October 2009 and began requiring hospitals to report present on admission (POA) indicators on their claims, not all hospitals were subject to the requirement – critical access hospitals, long-term acute care hospitals, inpatient psychiatric hospitals, and inpatient rehabilitation hospitals were exempt from the requirement. To more fully comply with the intent of the final rule, the IHCP has expanded its required POA indicator reporting to include all Medicaid-enrolled hospitals, including those previously exempt, effective July 1, 2012. 2012 Case Mix 101 Workshops scheduled for July

2012 Case Mix 101 Workshops, presented jointly by HP and Myers and Stauffer, the rate-setting contractor for Indiana Medicaid, are on the calendar for later this month. This workshop explains the Minimum Data Set (MDS) 3.0 application to the Resource Utilization Group (RUG)-III calculation, as well as coding instructions for the MDS 3.0 RUG-III items only. The updated Supportive Documentation Guidelines and the MDS audit protocol will be reviewed. A basic understanding of the MDS 3.0 is helpful.

Please note: This workshop is a REPEAT session of previous Case Mix 101 Workshops and will not cover prospective payment systems (PPS).
