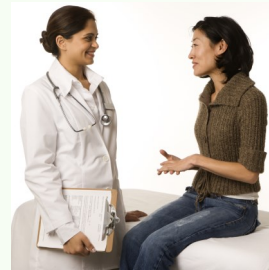

## IHCP corrects rate for CPT code 80410

The Indiana Health Coverage Programs (IHCP) has identified a claim-processing issue that affects fee-for-service (FFS) claims for Current Procedural Terminology (CPT®) code 80410 – *Calcitonin stimulation panel (eg, calcium, pentagastrin) this panel must include the following: Calcitonin (82308 x 3) with dates of service (DOS) on or after January 1, 2019*. The incorrect rate in the CoreMMIS claim-processing system was because of an error in the 2019 Centers for Medicare & Medicaid Services (CMS) [Clinical Laboratory Fee Schedule](#). As a result, FFS claims for code 80410 may have paid incorrectly.



The claim-processing system has been corrected. Effective immediately, providers may submit replacement claims for code 80410 for the affected DOS for reimbursement consideration. Providers must void the original claim before submitting the replacement claim. The replacement claim must include the same attachments that were submitted with the original claim. Replacement claims submitted beyond the original 180 day filing limit must include a copy of this banner page as an attachment and must be filed within 180 days of the publication date.

The correct rate will be reflected in the next regular update to the *Professional Fee Schedule* and to the *Outpatient Fee Schedule*, accessible from the [IHCP Fee Schedules](#) page at [in.gov/medicaid/providers](http://in.gov/medicaid/providers).
