## FSSA selects managed care entities to serve Healthy Indiana Plan and Hoosier Healthwise members

The Indiana Family and Social Services Administration (FSSA) Office of Medicaid Policy and Planning announces the procurement of four managed care entities (MCEs) that will serve members in the Healthy Indiana Plan (HIP) and Hoosier Healthwise programs beginning Jan. 1, 2023. As a result of the procurement process, the FSSA has begun negotiation with four selected MCEs: Anthem, Managed Health Services (MHS), MDwise and CareSource.

HIP is a healthcare program for qualified adults and pregnant individuals ages 19 to 64 who meet specific income requirements. Hoosier Healthwise is a healthcare program for children up to age 19 and pregnant individuals. These programs cover medical care such as doctor visits, prescription medicine, mental health care, dental care, hospitalizations and surgeries at little or no cost to the member or the member's family.

The FSSA remains focused on improving health outcomes, reducing administrative burden for members and providers, and the overall alignment of programs and benefits consistent with FSSA's mission, vision and values.

To participate in the HIP and Hoosier Healthwise MCE networks, providers must be enrolled with the Indiana Health Coverage Programs (IHCP) and be contracted with one or more of the MCEs. Providers currently contracted with an existing MCE may be required to enter into new contracts to remain in-network as of Jan. 1, 2023. Providers should contact the MCE directly for further direction. Table 1 lists contact information for each MCE for providers with questions about each MCE's credentialing and contracting processes.
